Official information request for information about the chief executive retreats

I refer to your official information request that was transferred to the State Services Commission (SSC) on 6 June 2017 for:

- Has the Chief Executive (CE) of Statistics New Zealand (Statistics) attended any meetings or conferences at Brackenridge Estate, in the current calendar year? If so,
 - What was the purpose of the meeting/conference(s)
 - Who attended from Statistics
 - Who were the other attendees
 - What other government agencies were represented at the meeting/conference
 - What was the speaker list, and nature of presentations made
 - What were the costs of attendance (including, but not limited to, activities, entertainment, fees, accommodation and travel)?

Attendance of CE of Statistics at CE meeting and purpose of meetings

The CE of Statistics, Ms Liz MacPherson, attended the CE meeting that was held in Brackenridge from 17 to 18 May 2017. No one else attended this meeting from Statistics.

Since 2014, CEs have been meeting together as a group twice a year. These working sessions are an important part of how the leaders of the Public Service work together to drive the Better Public Services agenda faster to make a bigger difference, and to make sure that New Zealanders are getting the best outcomes from their public services.

CEs highly value the time together, and want to be able to increase the pace of how they are driving and leading change. Planning and collective decision-making occurs at these meetings and it is important to ensure that changes takes place in a timely way. As a result, in 2017 the CEs agreed to increase the number of CE meetings, from two to four per year (2 overnight meetings, and 2 one day meetings in Wellington).

Cost of CE meetings and cost for non-attendees

The CE meetings are organised and convened by the State Services Commissioner. The State Services Commission (SSC) works hard to ensure that the costs for the meetings are kept as low as possible. Competitive rates for accommodation and transport are negotiated where possible, and some CEs share rooms and carpool to reduce costs. Since October 2016, the State Services Commissioner personally pays for all alcoholic beverages.

Please find attached as Appendix 1 a table that covers the total amount spent by SSC on the May 2017 CE meeting, with the cost broken down by:

- venue
- catering
- accommodation
- speakers' fees.

Note that all costs are GST exclusive. The table also lists each CE attendee and the agency that they represent, and the CEs who did not attend. There was no expenditure specifically on either activities, entertainment, travel, or other costs (e.g. internet usage, technical support, printing, stationery, and photocopying) for this meeting.

The total cost of the meeting includes any cost incurred by the other SSC staff who attended in support.

SSC did not recover costs from CEs for this meeting, which means that we are unable to break down the cost of the meeting per CE.

Speakers and presentations

You are also interested in the speaker list for the May 2017 CE meeting, and the nature of presentations made. The external speakers at this meeting were Mr Matthew Hooton and Mr Stephen Mills, who had an hour long session covering "the political landscape". CEs hosted other sessions during the meeting on a range of topics, including the state of the Public Service and its foundational pillars, and how the CEs can take their work forward as a team.
