Te Tohu mō te Kaiārahi Rangatahi o te Tau | Young Leader of the Year Award

Criteria

This award celebrates inspirational young public sector leaders who exemplify the spirit of service.

The judges will be looking for nominees who demonstrate spirit of service through:

- exceptional motivation and commitment to delivering for New Zealand and New Zealanders
- a collaborative approach to engaging and partnering with others
- setting ambitious goals and a track record early-in-career for delivering results
- actively supporting others.

Eligibility

Nominees must:

- be aged 35 years or under as at 31 December of the current year
- agree to be nominated
- be willing to present to a judging panel if selected as a finalist
- consent to the personal information in this entry form being provided to Te Kawa Mataaho | Public Service Commission and the external judging panel
- agree to the use of this information for publicity purposes
- consent to their nominating employer undertaking an integrity check, including of their current HR file and, if appropriate, the findings of that check being shared with Te Kawa Mataaho | Public Service Commission and the external judging panel
- consent to Te Kawa Mataaho | Public Service Commission undertaking additional integrity checks as required.

Judging

The judging co-chairs will select the finalists for each category. Finalists will be notified and asked to prepare a short video and attend a judging day in Wellington. The judging day involves a mihi whakatau, presentation and Q&A session with the judging panel.

Finalists will be announced on our Awards webpage and recognised on social media. We will work with finalists to arrange photographs and consent, and ensure the information we publish is accurate. Judges' decisions will be final.

All winners are announced at the Awards event in Wellington.
